Access Control: Controlling the Building Perimeter



There is a need to address crisis situations outside the norm at educational facilities. The mindset of “it can’t happen here” is not a viable option. It is critically important to address potential man-made and natural hazards. The options outlined below are baseline options to consider when reviewing exterior access countermeasures; this is not intended to be an all-inclusive list.

Definition of “Access Control” - The control of persons and materials entering into and moving within protected buildings or areas through one or more of the following measures:

Mechanical (locks, reinforced doors, etc. to deny or increase the effort to enter);

Organizational (policies and procedures using persons to guard or authorize entry);

Architectural (design of spaces and elements to bar or slow entry).

Common Vulnerabilities -

Lack of access control conditions;

Have access control conditions but lack a “security culture” for it to function properly;

Have access control but lack communication and training about why it was implemented;

No compliance requirement or structure for non-compliance;

Building doors unlocked or propped open;

Doors damaged or maladjusted so will not close properly;

Lack of planning for how to admit visitors and vendors;

Lack of buy-in from staff that must perform access control duties;

Lack of training for staff, student and parents.

Protective Measures -

Close and lock all exterior doors;

Monitor student arrival and dismissal times with sufficient staff members;

Do not allow any door to be propped open for any reason; use door alarms;

Implement comprehensive visitor/vendor authorization program;

Implement key control program or use electronic locks;

Implement door preventive maintenance program;

Remove access hardware from non-ingress exterior doors, add anti-intrusion latch plate and hinge protection ;

Maintain access control for after-hours programs;

Segregate unused parts of building during afterhours usages;

Train staff on techniques and importance of access control measures;

Provide appropriate signage to identify access points and areas with restricted access.

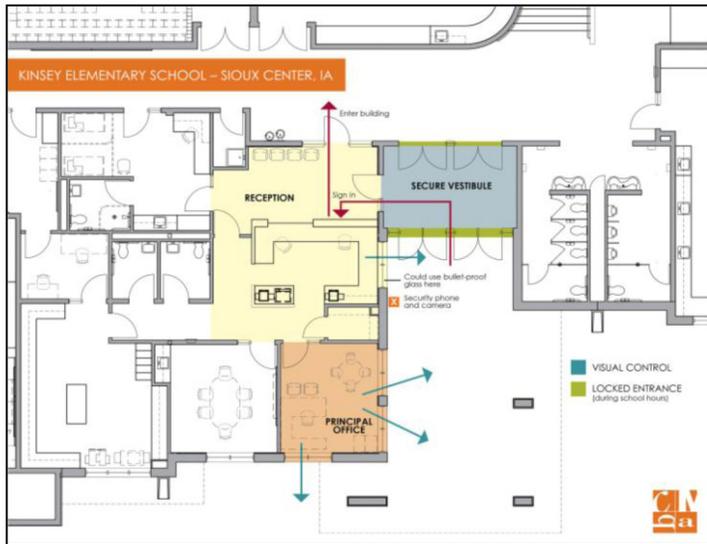
